



MEMORANDUM OF UNDERSTANDING

OBJECTIVES

The objective of this Memorandum of Understanding is:

COMMENCEMENT AND TERMINATION

This MoU will come into force upon affixing the signatures of the representatives of (DIBNS) and HWC, and will remain in effect until terminated by any one party. This MoU may be terminated by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MoU upon 30 days prior written notice to the other party.

RELATIONSHIP

Nothing in this MoU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.

ASSIGNMENT

It is understood by the Parties herein this MoU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

This MoU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.
